Strategic Location:

The State of Rio de Janeiro is located in the Southeast Region, the richest and most dynamic one of Brazil.

About 67% of the National GDP is concentrated in a radius of 500km around Rio's capital, which also allows easy access to the 209 million inhabitants of Mercosul.

Besides representing just 0,5% of the national territory, the state houses 8,5% of the total population, with the highest urbanization tax of the country – 96% of its population live in urban areas.

Competitive Logistics

Wide mesh of highways and railways connecting the state itself and the state to the other main regions of the country.

The dockland operation is controlled by the private initiative, with costs comparable to the international market. There are six ports placed along Rio's coast, three airports in the metropolitan area and ten in the other municipalities.



Qualified Labor

The state has massive concentration of universities, technologic centers and research institutions, with roughly 265 thousands college students and approximately 20 thousands researchers in activity.

The most important MBA centers of engineering are located in Rio, especially of informatics and telecommunications, and some of the major technologic parks of Latin America.
